  - Richard Stedman, APCO, reported on the following:

### **Engineering**

- Project to implement an Accela permit database to replace TRAKiT is making progress.
- The California Air Resources Board is continuing to move forward with an emission reporting regulation applicable to most permitted sources.
- District inspectors have been able to conduct some remote inspections working with permit holders to collect data and photographs.

• District asbestos team has also been able to conduct drive up inspections to observe abatement and/or demolition activities from their vehicles.

## Planning and Air Monitoring

- District staff have been working with MBCP to develop an agreement to provide \$1.2 million in funds toward the District's Zero Emission School Bus Program. The agreement is on the consent agenda for approval at this month's meeting.
- The Monterey Bay Electric Vehicle Incentive Program is continuing with 332 applications received, \$279,000 obligated, and \$121,000 remaining.
- On May 21 District staff will hold a workshop for installers and retailers participating in this
  year's Woodstove Change Out Program. The District has received \$175,000 in grant funds
  from CARB for the program.
- In early June, Camp Roberts will be conducting their annual prescribed burn of about 9,000 - 10,000 acres of grassland in their artillery ranges. District staff work closely with Camp Roberts and San Luis Obispo APCD staff to determine the smoke management requirements in order to limit smoke impacts on local communities such as Bradley, San Miguel and Paso Robles.
- Fire Season has officially started.

- We are in the process of producing an Air Quality 101 video for the Steinbeck Center's virtual summer camp in June.
- Will be publishing our first quarterly newsletter in June.
